C/ \$8,330.00 November 17, 2025

D/ \$8,330.00 February 17, 2026

**A non-refundable deposit is due with your signed contract (e-transfer preferred). To complete the enrollment process, you must provide post-dated written cheques or Pre-Authorized Debit (PAD) banking information/VOID cheque for the B/June, C/Nov. & D/Feb. installments. Post-dated cheques made payable to Boardwalk Montessori School Inc.**

Returned/NSF cheques are subject to a \$25.00 service charge. Please note: Families with two children enrolled, one in the Casa Program and one in the Pre-Casa Program, will pay full tuition fees for both placements. Boardwalk Montessori School Inc. refrains from offering a discount for two children in these separate programs.

I understand that tuition provides the only source of funds for Boardwalk Montessori School Inc. and that the functioning of the School is dependent upon the timely receipt of tuition payments. If I find it necessary to withdraw the Student from the School at any time for any reason, I agree that I am obligated to pay the full tuition fees for the Student for the full school year. There shall be no reduction or refund of fees in case of withdrawal, dismissal, absence, cancellation or non-attendance. Exception: If the cancellation occurs within 5 days of enrollment (cooling-off period), all fees will be refunded.

If the school recommends, at the School's sole discretion and determination, that the Student leaves, the refund shall be on a pro-rata amount (based on a 10-month year) of fees for the number of remaining months in the year, starting on the first day of the month following withdrawal.
